Mr. Lourenco serves as Investment Executive and Partner with Blantyre Capital Limited, and he disclaims beneficial ownership of the reported securities except to the extent of his pecuniary interest.

2. Blantyre Mulanje II GP Limited is the general partner of the fund entity that is an indirect owner of the securities of the Issuer that are held by Blantyre Mulanje II DAC. Blantyre Fund II (GP) Limited is the general partner of the fund entity that is an indirect owner of the securities of the Issuer that are held by BSSF II Ireland DAC. Blantyre Fund III (GP) Limited is the general partner of the fund entity that is an indirect owner of the securities of the Issuer that are held by BSSF III DAC.
